cluster sampling of seven middle schools in five urban chinese cities beijing shanghai guangzhou shenzhen and xiamen the final sample consisted of 1 549 adolescents of whom 90 had used social media using young s classic definition of internet addiction 15.6 of participants were classified as social media addicts the addicted adolescents were often self absorbed bored with their leisure time and good at using manipulation through social media for impression management addicts experienced four major social media addiction symptoms preoccupation adverse consequences alleviation of negative emotions and loss of interest in social activities the seven social media gratifications identified in this study can be categorized into social information and entertainment gratifications among these entertainment gratifications had the most power to predict social media addiction while information gratifications were the least likely to lead to addiction furthermore these gratifications were found to be powerful mediators between the adolescents sociopsychological traits and social media addiction finally the results also indicated that social media addiction and its symptoms had a significant negative impact on adolescents academic performance and social capital
